

### ONLINE ADMISSION NOTIFICATION 2025-26-27

In pursuance to Directorate of Skill Development J&K, Jammu's Admission Notice issued under endorsement No.DSD/401/Trgs/2025/1521-1611,dated 08-05-2025, **Online applications** are thus invited from the desirous candidates for seeking admission in **Govt. ITI Basohli** for the Academic session 2025-26-27 in various Engineering/Non-Engineering Trades as detailed below, having duration of One/Two years for **Free Seats/Self Finance Seats** being run under NCVT Scheme and the academic session is commencing from 1<sup>st</sup> September 2025 for which the forms can be uploaded from **15 May 2025 to 30 May 2025**.

The desirous candidates having minimum age of **14 years as on 1<sup>st</sup> September 2025** with no upper age bar have to fill up the admission forms online available at ITI admission portal (link) viz. (<https://itiadmissions.jkdsd.in>) present on the official website of Directorate of Skill Development (erstwhile Technical Education) J&K i.e. [www.jkdsd.in](http://www.jkdsd.in)

The last date for applying online is up to **30 May, 2025**. The details pertaining to trades functioning in Govt ITI Basohli for which Admissions are to be made for the session 2025-26-27 for free seats/ **Self Finance Seats** and are available on the portal and can also be sought from this institute.

The candidates have to fill up the complete details which include basic details like Name, Parentage, Qualification etc. online on the portal and have to upload the soft copies of the following documents online only:-

1. Marks Certificate of Qualifying examination.
2. Date of birth Certificate preferably 10<sup>th</sup> class Diploma /Marks Certificate.
3. Category Certificate (SC/ST/Ex-serviceman/Physically Handicapped/EWS) if any.
4. Aadhar Card.
5. Domicile Certificate should be produced at the time of admission in the ITI.

The candidates after finalizing the profile and application online will be required to deposit the print out of the system generated application in this Institute along with self attested photo copies of above mentioned required documents in this Institute and has to pay a fee of Rs. 100/- (Rupees One Hundred only) per three trades in which he/she is seeking admission against cash receipt from this Institute.

#### **Important Note:**

1. The applying candidate should be of Minimum 14 Years of age as on 01-09-2025. However there is no upper age limit.
2. The applying candidate has to submit the Printout of his/her System generated application alongwith the requisite self attested documents at Govt. ITI Basohli.
3. The candidate has to deposit a fee of Rs. 100/- (Rupees One Hundred only) per three trades in which he/she is seeking admission, at Govt. ITI Basohli, against a proper cash receipt from this Institute.
4. Selection will be made purely on the basis of Academic merit obtained by the applicants in their qualifying examination (for free seats/ Self Finance Seats).
5. On successful completion of training in trades running under NCVT scheme, certificate will be awarded by National Council for Vocational Training.
6. Candidates who have already undergone training in any of the trades in any ITI can apply for admissions in another trade after two years of completion of previous training course. However, for the ensuing academic session, their admission can be considered in any trade having poor response.
- 7. Selected Candidates should retain a consistent mobile number and e-mail address, till completion of course; until certification, as changes are not permitted by DGT.**
